## III. Event Guidelines and Release of Liability

FPAG's meetings and events may involve exposure to pyrotechnic items, hazardous materials, and potential inherent dangers. Pyrotechnics includes working with materials having the potential to cause harm to persons and property. In general, each individual is responsible for being properly trained/supervised and exercising safe conduct to protect ones self as well as other individuals and property. Specifically:

- **Alcohol consumption is not permitted** during the 8 hours prior to using ranges or manufacturing areas
- **Smoking is not permitted** in the vicinity of **energetic materials**
- **Firearms shall remain covered** everywhere other than a designated range, if one exists (open transport is not permitted)
- Only **FPAG/PGI certified pyrotechnic display operators** shall be on the **"B" range** when it is open for **shooting**.
- **No animals are permitted on ranges**

Your signature below affirms, while attending FPAG meetings or other events, you (1) understand the FPAG Safety Guidelines and any other special rules, (2) agree to abide by them, (3) agree to indemnify and hold harmless the Florida Pyrotechnic Arts Guild, Inc., FPAG officers, FPAG members, event organizers, hosts, and any other person(s) connected in any way, from any liability or other legal actions, and (4) understand violations and abuses of FPAG safety rules and convention conduct guidelines may result in suspension of event privileges and possible revocation of FPAG membership without refund.
